

## Bonaldo Dinghy 12' Club Rules & Regulations

### ART. 1 THE MISSION

Bonaldo Dinghy 12' Club appreciates and treasures the passion and the respect for nature and sport, and values beauty, elegance, freedom and challenges.

Bonaldo Dinghy 12' Club develops the passion and the enjoyment Dinghies bring to their owners, close friends and those supporting the ongoing Bonaldo legend by promoting the spirit of Dinghy.

Bonaldo Dinghy 12' Club intends to be a reference point for all its Members offering events, qualified services and outstanding opportunities while increasing the occasions for meetings and exchanges amongst Members.

### ART. 2 THE CLUBHOUSE

The Members may use the Clubhouse and take part in the activities of the [REDACTED] according to the regulations of its charter.

### ART. 3 CHAIR & CLUB ADMINISTRATION

Bonaldo Dinghy 12' Club is a non-profit organization, of unlimited duration.

The Chairman of zf media srl shall be the Chairman of Bonaldo Dinghy 12' Club.

The Bonaldo Dinghy 12' Club Chairman shall elect the members of the Governing Board from among the Members of Bonaldo Dinghy 12' Club.

The Governing Board shall consist of a maximum of three members including Members of the Board zf media srl, Full Members and Honorary Members.

The Chairman shall hold the deciding vote.

The Governing Board shall set the rules and regulations for Bonaldo Dinghy 12' Club.

### ART. 4 MEMBERSHIP

There are three Membership categories: Honorary Members, Full Members and Guest Members.

#### HONORARY MEMBER

Honorary Members may be invited to join Bonaldo Dinghy 12' Club by the Governing Board, chosen from among outstanding personalities of the international sailing world and those who continue to support the legend and the yachting values of Bonaldo Dinghy all over the world as well as develop the mission of Bonaldo Dinghy 12' Club.

#### FULL MEMBER

The owner of a Bonaldo Dinghy 12', from the moment of its acquisition and throughout the whole period of ownership, shall be a Full Member.

The spouse of an owner and all children over 18 years of age are entitled to Full Bonaldo Dinghy 12' Club membership.

#### GUEST MEMBER

Full Members will remain as Guest Members of Bonaldo Dinghy 12' Club after the sale of their Bonaldo by contacting the Bonaldo Dinghy 12' Club Manager.

Full Members, Honorary Members and the Governing Board may introduce new Guest Members.

Full Members wishing to introduce Guest Members must forward the request to the Bonaldo Dinghy 12' Club Manager.

Full Members may request the introduction of two guest members per year.

### ART. 5 BONALDO DINGHY 12' CLUB MEMBERSHIP CARD

Each Bonaldo Dinghy 12' Club Member shall receive a membership card enabling him or her to gain access to dedicated Bonaldo Dinghy 12' Club services, products and privileges.

The Full Member's Card is valid for the entire duration of the ownership. The Honorary Member's Card is for life. Guest membership is valid for one year, and can be renewed upon expiration by contacting the Bonaldo Dinghy 12' Club Manager.

The loss of a Membership Card must be communicated in writing to the Bonaldo Dinghy 12' Club Manager at [info@zfmedia.it](mailto:info@zfmedia.it) in order to arrange for its replacement.

### ART. 6 BONALDO DINGHY 12' CLUB MANAGER

Bonaldo Dinghy 12' Club has a dedicated Manager to assist Members with their requests for information and to handle the administration and coordination of the Club's activities. The Bonaldo Dinghy 12' Club Manager directs and supports Members for all the service assistance and customer care information and is situated in the Nautor's Swan headquarters in Florence.

### ART. 7 AIMS & ACTIVITIES

Bonaldo Dinghy 12' Club intends to fulfill the mission and generate benefits for its Members, identifying outstanding opportunities, facilitating the access and availability of qualified services, promoting and supporting events, activities and occasions for meeting. This includes privileges, access and invitations to selected boat shows, yachting related events and sea trials.

1. Bonaldo Dinghy 12' Club organizes and promotes Bonaldo Dinghy 12' related racing events. It supplies information about all the international sailing circuits and provides advice to Bonaldo Dinghy 12' Club Members taking part in its activities.

2. Reciprocal Programs: Bonaldo Dinghy 12' Club is aligned with some of the most prominent Yacht Clubs and institutions around the world with whom Reciprocal Agreements are in place for the exchange of hospitality, activities and privileges.

3. Privilege hospitality at selected marinas: Some of the best marinas around the world offer special benefits to Bonaldo Dinghy 12' Club Members.

4. Bonaldo Dinghy 12' Club will be present at all Bonaldo Dinghy 12' Club regattas to offer assistance and information to Members.

5. Participating in some of the activities and services of Bonaldo Dinghy 12' Club may involve the payment of a fee by the Member.
